Our Policy

Changes to your information online may only occur after you have logged in with a registered user name and password.

This data remains confidential and will only be used by the Community Foundation of Louisville. We authorize our employees to view your personal information only when necessary to serve you better. We will not share any information you provide to us with any other organization.
