The Oldham County Community Foundation is dedicated to enriching the quality of life for all citizens of Oldham County by serving the charitable interests of donors who have established charitable funds as part of a permanent, collective, philanthropic resource for the current and future needs of the Oldham County community. The Oldham County Community Foundation was organized in 2010 to provide the services of a community foundation to local residents and to begin building a collective charitable endowment for Oldham County.

The Oldham County Community Foundation strives to support local organizations through a competitive grantmaking program.

- In 2014, the Foundation granted \$16,150 to 11 nonprofit organizations
- In 2015, the Foundation granted \$19,450 to 13 nonprofit organizations
- In 2016, the Foundation granted \$26,735 to 13 nonprofit organizations
- In 2017, the Foundation granted \$23,117 to 13 nonprofit organizations
- In 2018, the Foundation granted \$23,325 to 14 nonprofit organizations
- In 2019, the Foundation granted \$43,729 to 21 nonprofit organizations

The Oldham County Community Foundation is an affiliate foundation of the Community Foundation of Louisville, a tax-exempt public charity that administers charitable funds created by individuals, businesses and organizations for the betterment of their communities.
