<p><b>Affordable Housing Fund</b> Offers support to nonprofits that provide affordable housing for low-income individuals and families in Metro Louisville, including construction and foreclosure prevention programs.</p>	<p><b>Morris and Esther Lee Fund</b> Offers support to organizations that provide human services, excluding civic, conservation, arts, or religious organizations.</p>
<p><b>The AIDS Project Fund</b> Provides grants to support HIV prevention, education, and testing.</p>	<p><b>Dr. W. Barnett Owen Memorial Fund</b> Created by Dr. Albert P. Williams to honor the memory of Dr. W. Barnett Owen, a children’s health care activist, by assisting the children of Louisville and Jefferson County, Kentucky.</p>
<p><b>Winston N. and Nancy H. Bloch Educational Fund</b> Created by Mary C. Jones in memory of her son and daughter-in-law to help children learn by providing schools with grants to support nontraditional classroom resources.</p>	<p><b>Dennis Reker Fund</b> Supports community-building projects in historically disinvested neighborhoods in the Louisville area, with an emphasis on utilizing technology and increasing access to technology as a means to strengthen the sense of community.</p>
<p><b>Boyette and Edna Edwards Fund</b> Established by the remainder of the Lucille E. Crosby Charitable Remainder Trust to honor her parents with annual grants that support the needs of children in Jefferson County.</p>	<p><b>Madi and Jim Tate Fund</b> Established by Terry “Madi” Tate to support the education of disadvantaged youth with priority given to Louisville’s African American community.</p>
<p><b>George and Mary Alice Hadley Fund</b> Created by a transfer of assets in the Mary Alice Hadley Foundation to support the visual arts, crafts, theater, and the Louisville Free Public Library.</p>	<p><b>T. Bert and Bertha Wilson Fund</b> Established by the remainder of the Lucille E. Crosby Charitable Remainder Trust to honor her great aunt and uncle with annual grants that support the arts and humanities, including, but not limited to, museums, music, theater, dance, painting, photography, and historic preservation.</p>
<p><b>Historic Preservation Fund</b> Established by Edith S. Bingham to support the preservation of historic resources in Jefferson County, Kentucky.</p>
