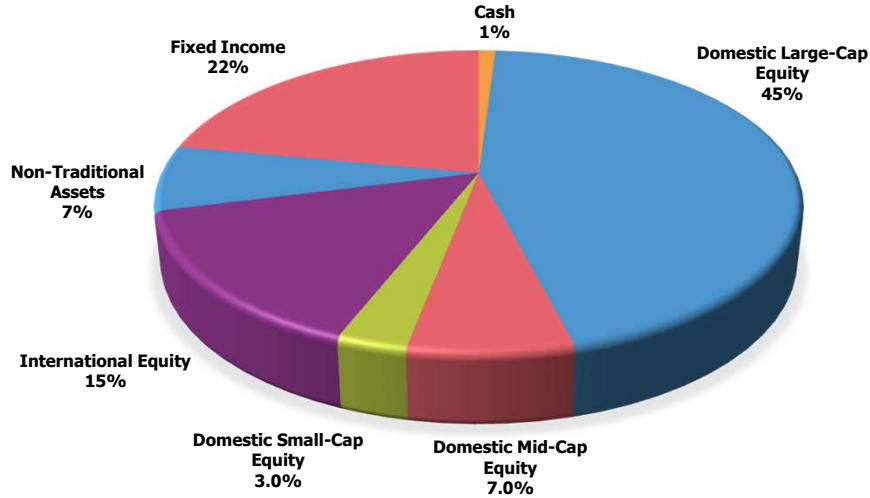


We are pleased to provide this quarterly update for your fund's investment in the Community Foundation's **Commonwealth Pool**.

The Pool is designed to generate moderate growth in long-term returns by investing in a diversified portfolio of equities, fixed income, and non-traditional assets. It employs a combination of active and passive investment management styles that are structured to maintain the purchasing power of principal and support distributions to grantees.

The Pool's Strategic Asset Allocation is 70% traditional equities, 23% fixed income and cash, and 7% non-traditional assets. A more detailed breakdown is shown below:


