# **CHARITABLE CHECKING FUND**

#### WHAT IS A CHARITABLE CHECKING FUND?

A Charitable Checking Fund is a pass-through charitable fund that supports charitable giving throughout your lifetime. There is no minimum balance requirement and no fee.

#### **GETTING STARTED IS EASY**

Open your charitable fund in only minutes by completing a short form. Contribute cash, stock, or other assets into your fund, and qualify for an immediate tax deduction. Then, when it's convenient for you, choose the charitable organizations you want to support with grants out of your fund.

#### **KEY BENEFITS:**

**Flexible:** Grants from your fund must be a minimum of \$100 and may be distributed to any qualified 501(c)(3) public charity in the United States as well as certain other tax-exempt organizations. Fund assets are not invested, but as your goals and resources change over time, you may convert your Charitable Checking Fund to a Donor Advised or any invested fund.

**Customizable:** Give your fund your name or call it something that is significant to you. Enjoy the flexibility to give in whatever capacity you feel most comfortable, as well as adjust your giving preferences over time. Through the Community Foundation, you may choose to grant money to charitable organizations anonymously and on a schedule through recurring grants.

**Convenient:** Manage your fund just like you manage your bank account. Through our modern online platform, you can view fund activity, download digital tax receipts, and recommend grants from a laptop or phone. Or give our friendly team a call for the same great service. Your full gift and grant history is available at any time.

**Trusted:** When you collaborate with us, you'll have access to a dedicated local team that is committed to helping you achieve your charitable goals.
